Motorcycle-insurance.com.au is an Authorised Representative (AR) of QBE Insurance (Australia) Limited (QBE).

Motorcycle-insurance.com.au is authorised by QBE to deal in QBE Motorcycle and Consumer Credit insurance products on their behalf. We can directly issue, vary or cancel QBE Motorcycle and Consumer Credit insurance products as their agent in accordance with their underwriting guidelines (this is called a binder authority).

In some cases we may need to arrange for QBE to do this if we are not able to act under our binder authority. QBE as the insurer of the product and we, as their agent, do not act on your behalf.

Motorcycle-insurance.com.au dealer providing you with this FSG is authorised by us to act on our behalf in providing the services we are authorised to provide for QBE Insurance.

We and our dealers have authority to give you general advice only. We are not able to tell you whether a product is appropriate for you specifically. Because of this, you need to consider the appropriateness of any general advice or information given having regard to your personal objectives, financial situation and needs. We strongly recommend that you read the information contained in the Product Disclosure Statement provided to you before you make a decision.

REMUNERATION**

We receive commission from QBE, which ranges from 0% to 30% of the total premium payable (excluding government charges) by you to them for the product. The commission is paid to us by QBE for each policy issued or renewed. We may also be eligible to qualify for other benefits such as prizes, awards or hospitality events to the value of 1% of this commission. Commission for Consumer Credit insurance policies does not exceed 20% of the total premium (excluding government charges).

Motorcycle-insurance.com.au employees are paid an annual salary. Bonus payments or rewards may also be paid if certain sales targets are achieved. Bonuses are based upon sales targets for all of the activities of our staff, not only those related to financial services.
